

# Fisher Funds KiwiSaver Scheme Conservative Fund

Quarterly disclosure statement for 1 July 2015 to 30 June 2016

## What is the purpose of this statement?

This statement provides key information about the Fisher Funds KiwiSaver Scheme Conservative Fund. It tells you how the fund has performed and what fees it charged, and will help you to compare it with other funds. We prepared this statement in accordance with the KiwiSaver (Periodic Disclosure) Regulations 2013. This information is not audited and may be updated.

## Description of the fund

The Conservative Fund invests principally in cash and fixed interest securities but may also invest in shares, infrastructure securities and property securities (in each case either locally and/or internationally). The investment objective is to achieve long-term returns that are better than bank term deposits.

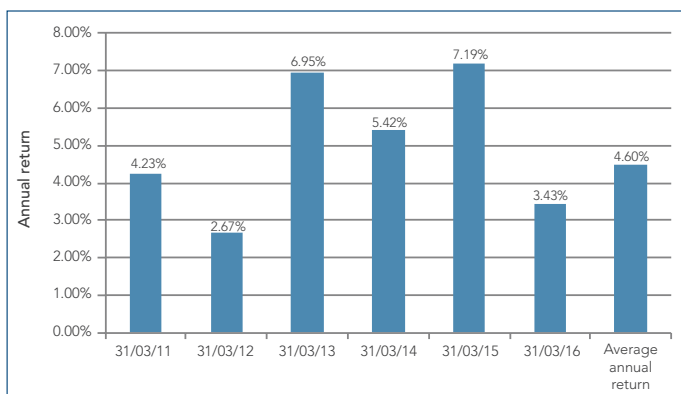

## How has the fund performed in the past?

## What fees were members charged?

The returns shown are after deductions for **fund fees**<sup>2</sup>. These fees were last totalled up for the year to 31/03/2016 and were:

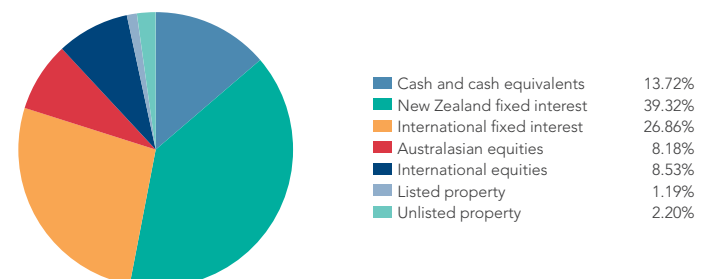
## Example of how this applies to a member

Jenny had \$10,000 in the fund at the start of the year and didn't make any further contributions. At the end of the year, Jenny received a return after fund fees and tax were deducted of \$483 (that's 4.83% of her initial \$10,000). Jenny also paid \$36 in membership fees. This gives Jenny a total return of \$447 for the year.
