
### **DESCRIPTION OF THIS FUND**

The fund aims to protect your investment and provide a return that is better than 90-day bank bills. Invested in New Zealand cash and New Zealand short term fixed interest assets.

## WHAT ARE THE RISKS OF INVESTING?

Risk indicator for the CashPlus Fund:



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.



# WHAT FEES ARE INVESTORS CHARGED?

Investors in the CashPlus Fund are charged fund charges that include GST. In the year to 31 March 2020 these were:


#### EXAMPLE OF HOW THIS APPLIES TO AN INVESTOR

Sarah had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Sarah received a return after fund charges were deducted of \$86 (that is 0.86% of her initial \$10,000). Sarah did not pay other charges. This gives Sarah a total return after tax of \$86 for the year.


#### **Actual investment mix**
