
DESCRIPTION OF THIS FUND

The fund aims to provide stable returns and reduce the potential of capital loss over the short to medium term by investing in New Zealand cash and New Zealand short term fixed interest assets.

WHAT ARE THE RISKS OF INVESTING?

Risk indicator for the CashPlus Fund:



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.



HOW HAS THE FUND PERFORMED?


EXAMPLE OF HOW THIS APPLIES TO AN INVESTOR

Sarah had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Sarah incurred a loss after fund charges were deducted of -\$46 (that is -0.46% of her initial \$10,000). Sarah did not pay other charges. This gives Sarah a total loss after tax of -\$46 for the year.


Actual investment mix

NOTES

¹ As a result of a decrease in the Manager's basic fee to 0.51% on 1 July 2021, the estimated total fund charge that is likely to be charged in the future is 0.68%.
