#### WHAT IS THE PURPOSE OF THIS UPDATE?

This document tells you how the Fisher Funds Global Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.



#### **HOW HAS THE FUND PERFORMED?**

# WHAT FEES ARE INVESTORS CHARGED?

Investors in the Global Fund are charged fund charges that include GST. In the year to 31 March 2021 these were:


# EXAMPLE OF HOW THIS APPLIES TO AN INVESTOR

Sarah had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Sarah received a return after fund charges were deducted of \$3,242 (that is 32.42% of her initial \$10,000). Sarah did not pay other charges. This gives Sarah a total return after tax of \$3,242 for the year.

### **Currency hedging**

The benchmark currency hedge ratio for International equities is 50% hedged into NZD. At quarter end the fund was 44.3% hedged into NZD.
