### WHAT IS THE PURPOSE OF THIS UPDATE?

The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.



### **HOW HAS THE FUND PERFORMED?**

# WHAT FEES ARE INVESTORS CHARGED?

Investors in the Global Fund are charged fund charges that include GST. In the year to 31 March 2020 these were:


# EXAMPLE OF HOW THIS APPLIES TO AN INVESTOR

Sarah had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Sarah received a return after fund charges were deducted of \$526 (that is 5.26% of her initial \$10,000). Sarah did not pay other charges. This gives Sarah a total return after tax of \$526 for the year.

### **Currency hedging**

The benchmark currency hedge ratio for International equities is 50% hedged into NZD. At quarter end the fund was 42.5% hedged into NZD.
