## What is the purpose of this update?

This document tells you how the Fisher Funds Multi Sector Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. Fisher Funds Management Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

## Description of this fund

The fund aims to provide a balance between protecting your investment and growing it over the long term by investing in a balance of income and growth assets.

The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.



# How has the fund performed?

## Annual return graph



This shows the return after fund charges and tax for each of the last 10 years ending 31 March. The last bar shows the average annual return for the last 10 years, up to 30 September 2018.

Returns in this update are after tax at the highest prescribed investor rate (PIR) of tax for an individual New Zealand resident. Your tax may be lower. The market index return reflects no deduction for charges and tax.

### What fees are investors charged?

Investors in the Multi Sector Fund are charged fund charges that include GST. In the year to 31 March 2018 these were:

Small differences in fees and charges can have a big impact on your investment over the long term.

# Example of how this applies to an investor

Sarah had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Sarah received a return after fund charges were deducted of \$771 (that is 7.71% of her initial \$10,000). Sarah did not pay other charges. This gives Sarah a total return after tax of \$771 for the year.
