### What is the purpose of this update?

This document tells you how the Fisher Funds Trans Tasman Equity Trust has performed and what fees were charged. The document will help you to compare the fund with other funds. ### What are the risks of investing?

Risk indicator for the Trans Tasman Equity Trust:

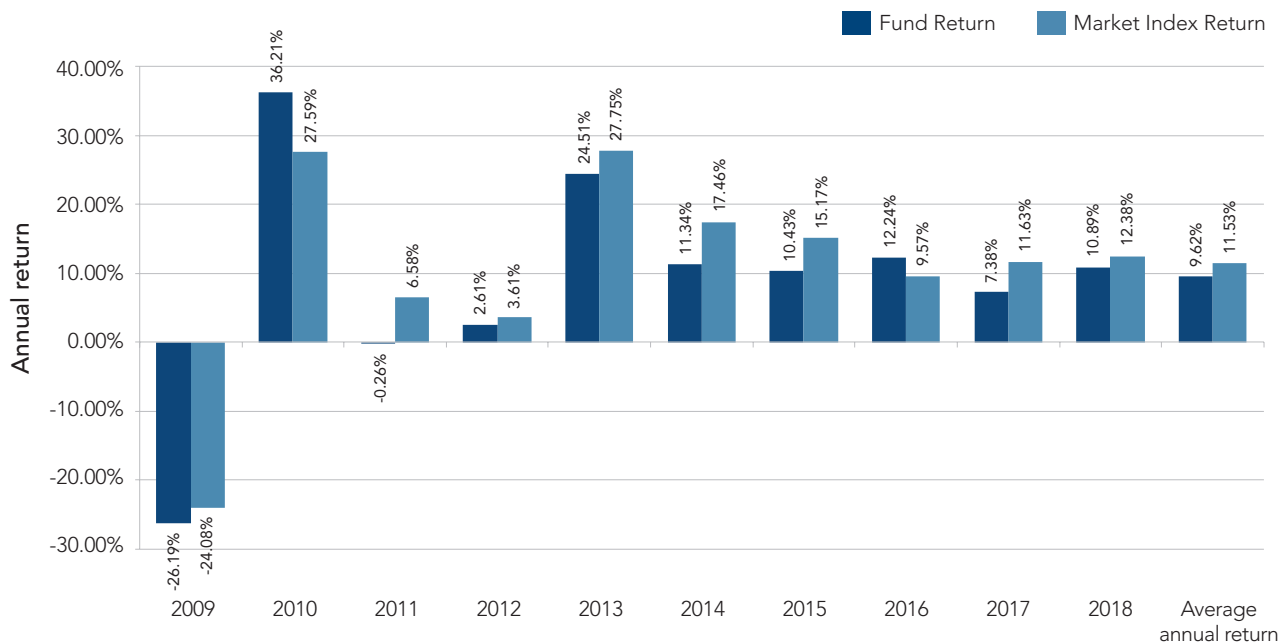

### How has the fund performed?

## Annual return graph



This shows the return after fund charges and tax for each of the last 10 years ending 31 March. The last bar shows the average annual return for the last 10 years, up to 30 June 2018.

## What fees are investors charged?

Investors in the Trans Tasman Equity Trust are charged fund charges that include GST. In the year to 31 March 2018 these were:

Small differences in fees and charges can have a big impact on your investment over the long term.

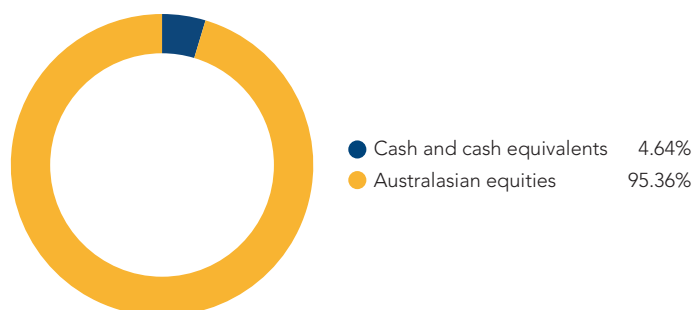
## Example of how this applies to an investor

Sarah had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Sarah received a return after fund charges were deducted of \$1,926 (that is 19.26% of her initial \$10,000). Sarah did not pay other charges. This gives Sarah a total return after tax of \$1,926 for the year.

## Currency hedging

The benchmark currency hedge ratio for Australian equities is 70% hedged into NZD. As at 30 June 2018 the fund was 70.1% hedged into NZD.
