### WHAT IS THE PURPOSE OF THIS UPDATE?

This document tells you how the Conservative Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. Fisher Funds Management Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

### **DESCRIPTION OF THIS FUND**

The fund aims to provide stable returns over the long term by investing mainly in income assets with a modest allocation to growth assets.

### WHAT ARE THE RISKS OF INVESTING?

The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.



### **HOW HAS THE FUND PERFORMED?**

# WHAT FEES ARE INVESTORS CHARGED?

Small differences in fees and charges can have a big impact on your investment over the long term.

# EXAMPLE OF HOW THIS APPLIES TO AN INVESTOR

Sarah had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Sarah received a return after fund charges were deducted of -\$639 (that is -6.39% of her initial \$10,000). Sarah also paid \$20.25 in other charges. This gives Sarah a total loss after tax of -\$659.25 for the year.
