WHAT IS THE PURPOSE OF THIS UPDATE?

This document tells you how the LifeSaver Equity Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. The fund aims to predominantly focus on the capital growth of your savings over the long term. Invests in local and global share markets with a low focus on capital protection.

WHAT ARE THE RISKS OF INVESTING?



HOW HAS THE FUND PERFORMED?

WHAT FEES ARE INVESTORS CHARGED?

Small differences in fees and charges can have a big impact on your investment over the long term.

EXAMPLE OF HOW THIS APPLIES TO AN INVESTOR

Sarah had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Sarah incurred a loss after fund charges were deducted of -\$106 (that is -1.06% of her initial \$10,000). Sarah also paid \$101.50 in other charges. This gives Sarah a total loss after tax of -\$207.50 for the year.
