WHAT IS THE PURPOSE OF THIS UPDATE?

This document tells you how the LifeSaver Growth Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. WHAT ARE THE RISKS OF INVESTING?

Risk indicator for the LifeSaver Growth Fund:



HOW HAS THE FUND PERFORMED?

WHAT FEES ARE INVESTORS CHARGED?

Small differences in fees and charges can have a big impact on your investment over the long term.

EXAMPLE OF HOW THIS APPLIES TO AN INVESTOR

Sarah had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Sarah received a return after fund charges were deducted of \$672 (that is 6.72% of her initial \$10,000). Sarah also paid \$95.83 in other charges. This gives Sarah a total return after tax of \$576.17 for the year.
