#### WHAT IS THE PURPOSE OF THIS UPDATE?

This document tells you how the LifeSaver Growth Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. Fisher Funds Management Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.



#### **HOW HAS THE FUND PERFORMED?**

# WHAT FEES ARE INVESTORS CHARGED?

Investors in the LifeSaver Growth Fund are charged fund charges that include GST. In the year to 31 March 2018 these were:

# EXAMPLE OF HOW THIS APPLIES TO AN INVESTOR

Sarah had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Sarah received a return after fund charges were deducted of \$775 (that is 7.75% of her initial \$10,000). Sarah also paid \$93.41 in other charges. This gives Sarah a total return after tax of \$681.59 for the year.
