
# **DESCRIPTION OF THIS FUND**

# WHAT ARE THE RISKS OF INVESTING?

Risk indicator for the LifeSaver Growth Fund:



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.



# HOW HAS THE FUND PERFORMED?

# WHAT FEES ARE INVESTORS CHARGED?

Investors in the LifeSaver Growth Fund are charged fund charges that include GST. In the year to 31 March 2021 these were:

Small differences in fees and charges can have a big impact on your investment over the long term.

### EXAMPLE OF HOW THIS APPLIES TO AN INVESTOR

Sarah had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Sarah received a return after fund charges were deducted of \$107 (that is 1.07% of her initial \$10,000). Sarah also paid \$65.39 in other charges. This gives Sarah a total return after tax of \$41.61 for the year.
