
DESCRIPTION OF THIS FUND

WHAT ARE THE RISKS OF INVESTING?

Risk indicator for the LifeSaver Preservation Fund:



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.




Small differences in fees and charges can have a big impact on your investment over the long term.

EXAMPLE OF HOW THIS APPLIES TO AN INVESTOR

Sarah had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Sarah received a return after fund charges were deducted of \$170 (that is 1.70% of her initial \$10,000). Sarah also paid \$101.50 in other charges. This gives Sarah a total return after tax of \$68.50 for the year.


WHAT DOES THE FUND INVEST IN? Actual investment mix
