## WHAT IS THE PURPOSE OF THIS UPDATE?

This document tells you how LifeSaver Trans Tasman Equity Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. ## WHAT ARE THE RISKS OF INVESTING?

Risk indicator for the LifeSaver Trans Tasman Equity Fund:

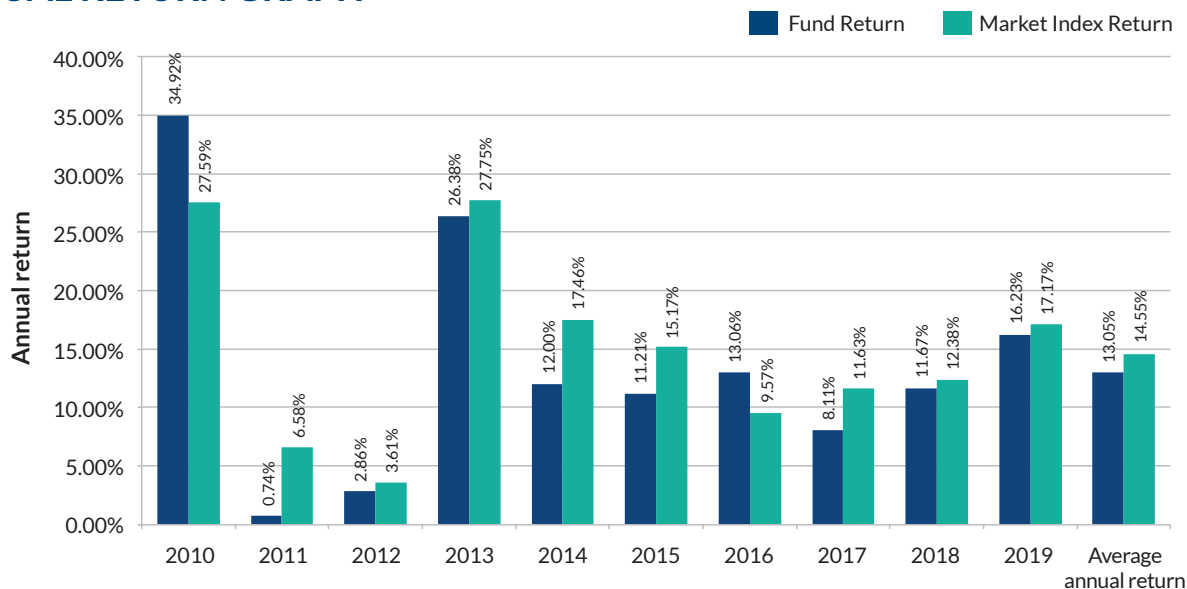

## HOW HAS THE FUND PERFORMED?

## ANNUAL RETURN GRAPH

## WHAT FEES ARE INVESTORS CHARGED?

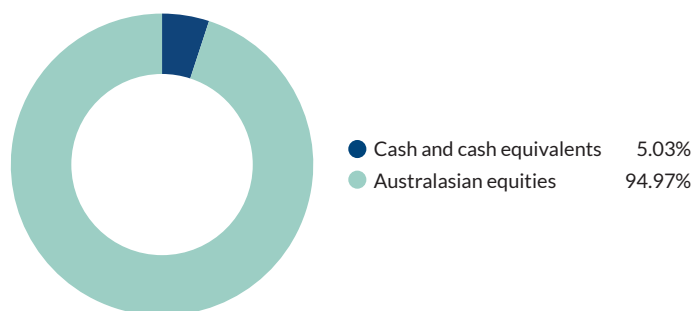
## EXAMPLE OF HOW THIS APPLIES TO AN INVESTOR

Sarah had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Sarah received a return after fund charges were deducted of \$1,384 (that is 13.84% of her initial \$10,000). Sarah also paid \$101.50 in other charges. This gives Sarah a total return after tax of \$1,282.50 for the year.

## WHAT DOES THE FUND INVEST IN?

## Currency hedging

The benchmark currency hedge ratio for Australian equities is 70% hedged into NZD. At quarter end the fund was 69.9% hedged into NZD.
