What is the purpose of this update?

This document tells you how the LifeSaver Balanced Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. Fisher Funds Management Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

Description of this fund

The fund aims to provide a balance between protecting your savings and growing them over the long term. Invested in a balance of income and growth assets.

Note that even the lowest category does not mean a risk-free investment, and there are other risks that are not captured by this rating.



How has the fund performed?

What fees are investors charged?

Investors in the LifeSaver Balanced Fund are charged fund charges. In the year to 31 March 2017 these were:

Small differences in fees and charges can have a big impact on your investment over the long term.

Example of how this applies to an investor

Sarah had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Sarah received a return after fund charges were deducted of \$985 (that is 9.85% of her initial \$10,000). Sarah also paid \$97.76 in other charges. This gives Sarah a total return after tax of \$887.24 for the year.

What does the fund invest in?

Currency hedging

The benchmark currency hedge ratios for each asset class (hedged into NZD) are: International fixed interest 100%; Listed property (overseas portion) 70%; Australian equities 70%; International equities 50%.

¹ The amount of the other charges is an estimate and may vary between Employer Schemes. Refer to your employer supplement for the actual fees charged to your LifeSaver account.

² The market index return has changed since the last fund update. The market index return is now calculated using the S&P/NZX50 Gross Index including imputation credits and the S&P/NZX All Real Estate Index including imputation credits for the fund's allocation to New Zealand equities and Unlisted property. This change has been made to better align the fund return to the market index return.
