This is a replacement fund update, which replaces the 30 June 2017 fund update made publicly available on 28 July 2017. An update has been made to change the Average annual return fund return. The figure provided used the return of the fund since its inception, however this return should have been the annualised return for the last 10 years.

What is the purpose of this update?

This document tells you how the LifeSaver Balanced Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. 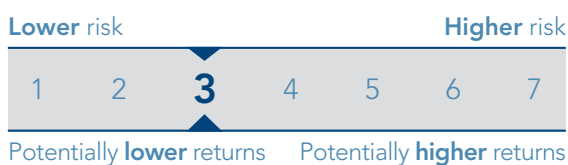
Description of this fund

What are the risks of investing?

Risk indicator for the LifeSaver Balanced Fund:



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.

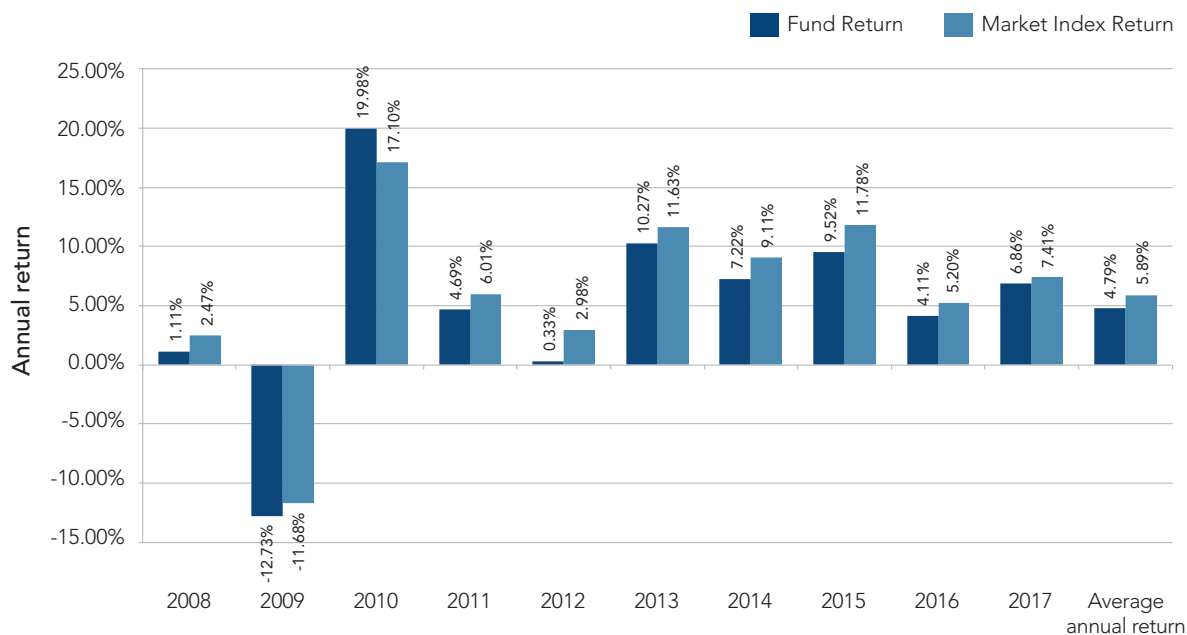

How has the fund performed?

Small differences in fees and charges can have a big impact on your investment over the long term.

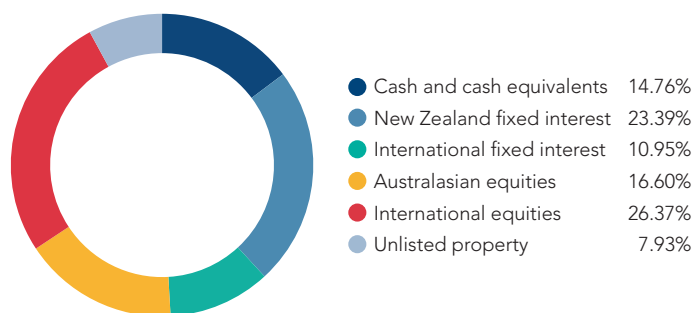
Example of how this applies to an investor

Sarah had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Sarah received a return after fund charges were deducted of \$734 (that is 7.34% of her initial \$10,000). Sarah also paid \$97.76 in other charges. This gives Sarah a total return after tax of \$636.24 for the year.

What does the fund invest in?

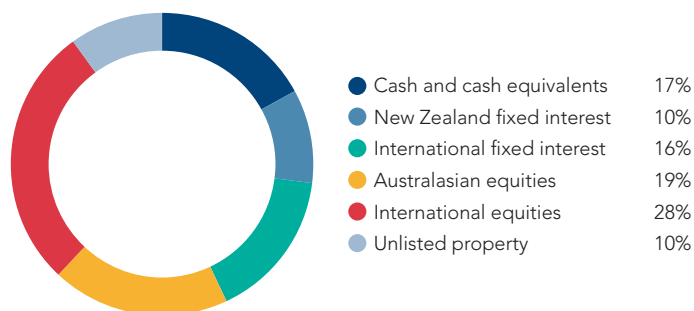
Actual investment mix

Currency hedging

The benchmark currency hedge ratios for each asset class (hedged into NZD) are: International fixed interest 100%; Listed property (overseas portion) 70%; Australian equities 70%; International equities 50%.
