
Description of this fund

What are the risks of investing?

Risk indicator for the LifeSaver Equity Fund:

Note that even the lowest category does not mean a risk-free investment, and there are other risks that are not captured by this rating.



How has the fund performed?

Small differences in fees and charges can have a big impact on your investment over the long term.

Example of how this applies to an investor

Sarah had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Sarah received a return after fund charges were deducted of \$600 (that is 6.00% of her initial \$10,000). Sarah also paid \$88.09 in other charges. This gives Sarah a total return after tax of \$511.91 for the year.

What does the fund invest in?

Currency hedging
