What is the purpose of this update?

This document tells you how the LifeSaver Equity Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. Fisher Funds Management Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

Description of this fund

The fund aims to predominantly focus on the capital growth of your savings over the long term. Invests in local and global share markets with a low focus on capital protection.

What are the risks of investing?

Risk indicator for the LifeSaver Equity Fund:



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.

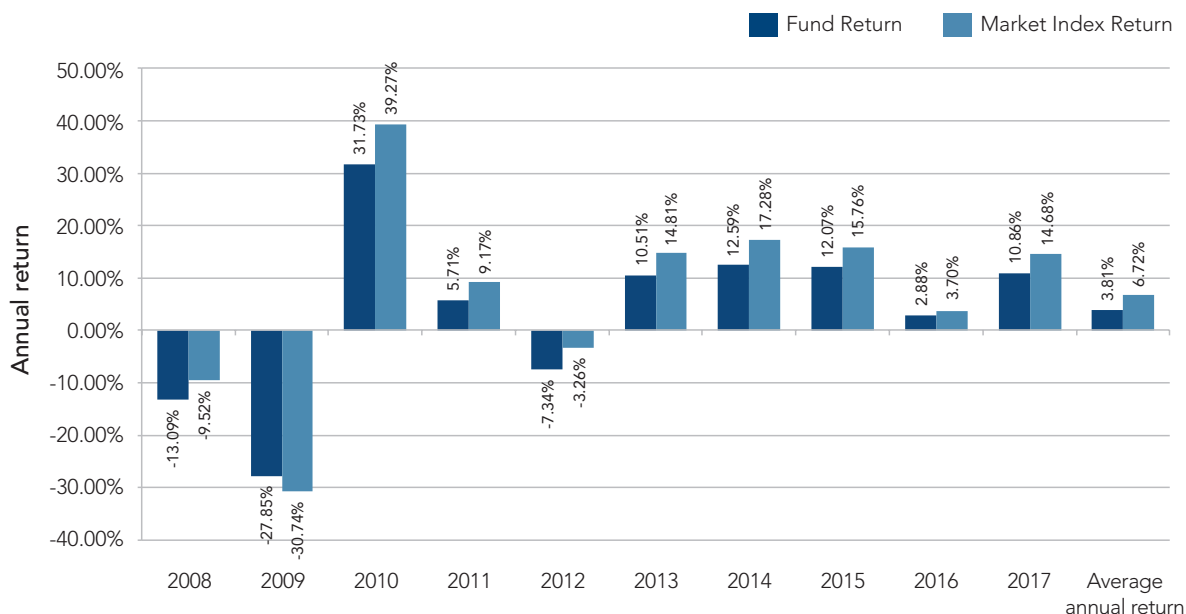

How has the fund performed?

Annual return graph



This shows the return after fund charges and tax for each of the last 10 years ending 31 March. The last bar shows the average annual return for the last 10 years, up to 31 December 2017.

Small differences in fees and charges can have a big impact on your investment over the long term.

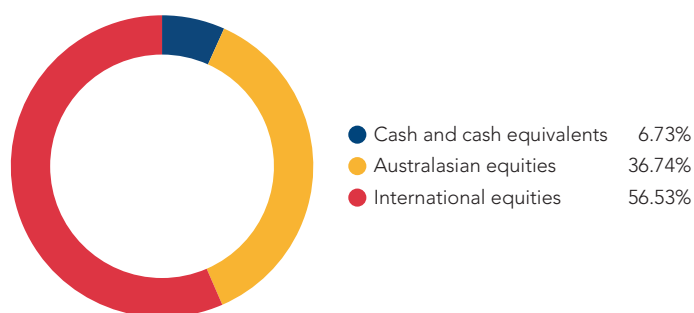
Example of how this applies to an investor

Sarah had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Sarah received a return after fund charges were deducted of \$1,746 (that is 17.46% of her initial \$10,000). Sarah also paid \$97.76 in other charges. This gives Sarah a total return after tax of \$1,648.24 for the year.

What does the fund invest in?

Currency hedging

The benchmark currency hedge ratios for each asset class (hedged into NZD) are: Australian equities 70%; International equities 50%.

The market index return is now calculated using the S&P/NZX50 Gross Index including imputation credits for the fund's allocation to New Zealand equities. This change has been made to better align the fund return to the market index return.
