What is the purpose of this update?

What are the risks of investing?

Risk indicator for the LifeSaver Growth Fund:



How has the fund performed?

Annual return graph

Small differences in fees and charges can have a big impact on your investment over the long term.

Example of how this applies to an investor

Sarah had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Sarah received a return after fund charges were deducted of \$585 (that is 5.85% of her initial \$10,000). Sarah also paid \$88.09 in other charges. This gives Sarah a total return after tax of \$496.91 for the year.

What does the fund invest in?

Currency hedging

The benchmark currency hedge ratios for each asset class (hedged into NZD) are: International fixed interest 100%; Listed property (overseas portion) 70%; Australian equities 70%; International equities 50%.
