
Description of this fund

What are the risks of investing?

Risk indicator for the LifeSaver New Zealand Fixed Income Fund:



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.



How has the fund performed?

Small differences in fees and charges can have a big impact on your investment over the long term.

Example of how this applies to an investor

Sarah had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Sarah received a return after fund charges were deducted of \$426 (that is 4.26% of her initial \$10,000). Sarah also paid \$97.76 in other charges. This gives Sarah a total loss after tax of \$328.24 for the year.
