Fisher Funds LifeSaver Plan Trans Tasman Equity Fund

This is a replacement fund update, which replaces the 30 September 2017 fund update made publicly available on 30 October 2017. An update has been made to change the Average annual return fund return. The figure provided used the return of the fund since its inception, however this return should have been the annualised return for the last 10 disclosure years.

What is the purpose of this update?

This document tells you how LifeSaver Trans Tasman Equity Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. Fisher Funds Management Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

What are the risks of investing?

Risk indicator for the LifeSaver Trans Tasman Equity Fund:

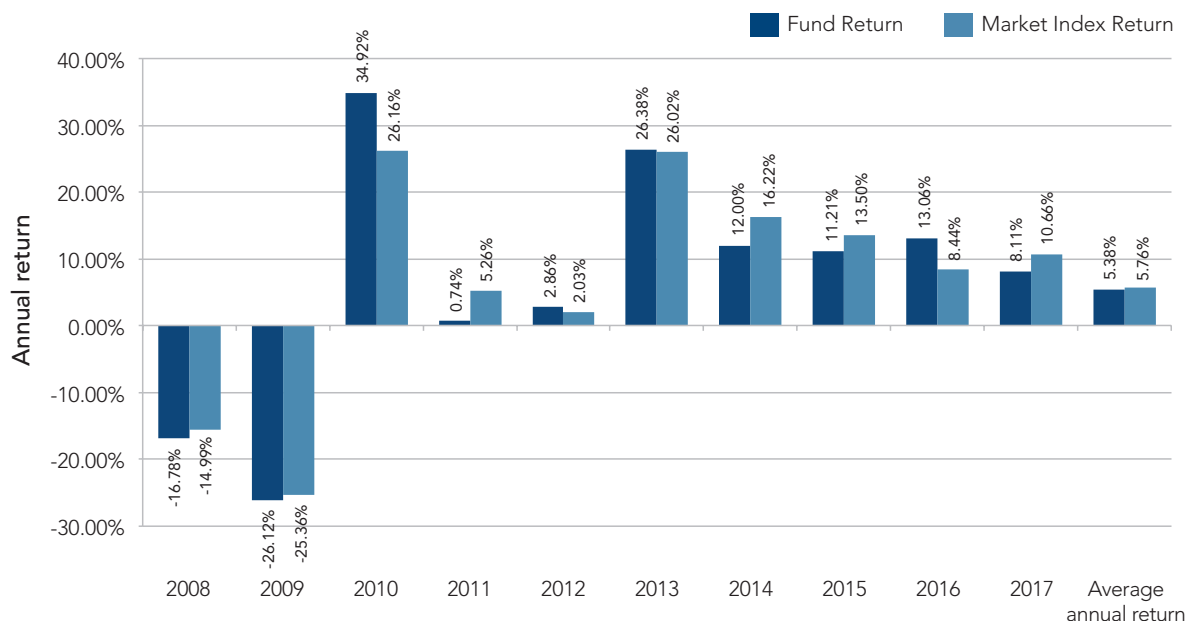

How has the fund performed?

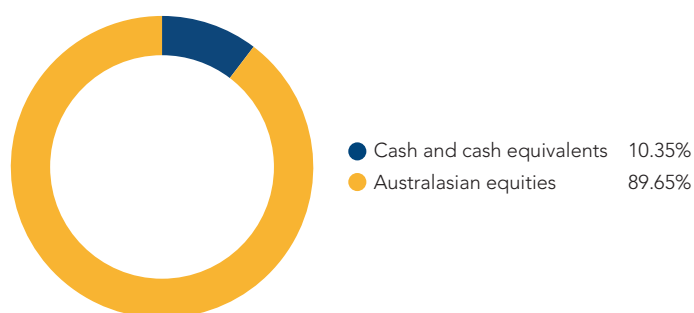
Example of how this applies to an investor

Sarah had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Sarah received a return after fund charges were deducted of \$459 (that is 4.59% of her initial \$10,000). Sarah also paid \$97.76 in other charges. This gives Sarah a total return after tax of \$361.24 for the year.
