What is the purpose of this update?

This document tells you how the Australian Growth Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. The fund aims to achieve capital growth over the long term by investing in quality Australian companies who can consistently produce increasing earnings.

What are the risks of investing?

Risk indicator for the Australian Growth Fund:



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.

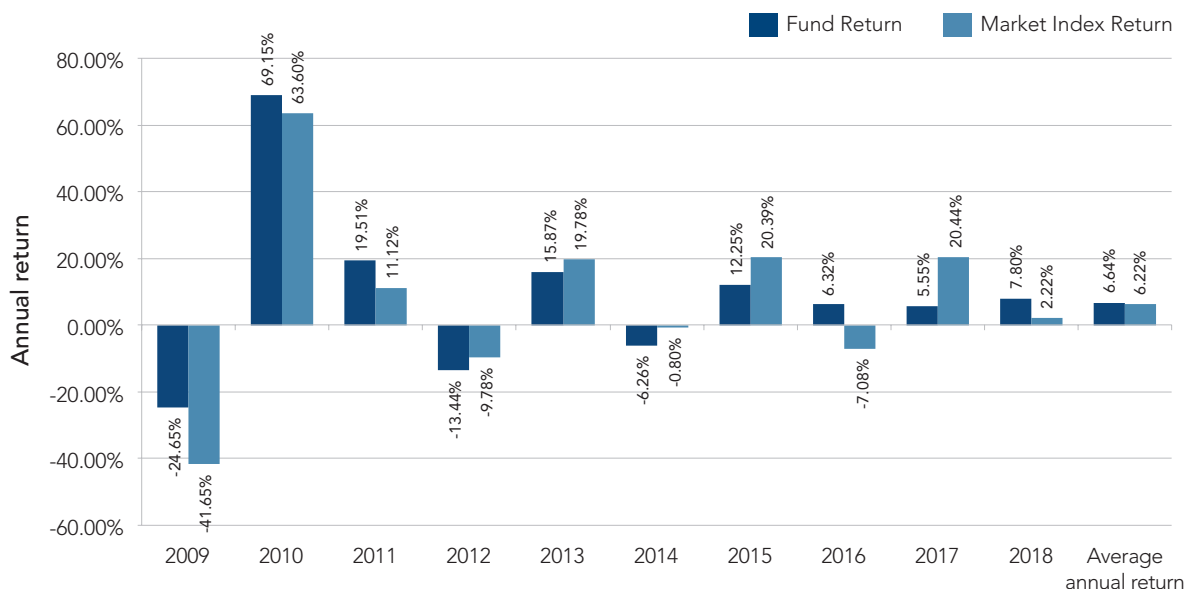

How has the fund performed?

This shows the return after fund charges and tax for each of the last 10 years ending 31 March. The last bar shows the average annual return for the last 10 years, up to 30 June 2018.

What fees are investors charged?

Investors in the Australian Growth Fund are charged fund charges that include GST. In the year to 31 March 2018 these were:

Small differences in fees and charges can have a big impact on your investment over the long term.

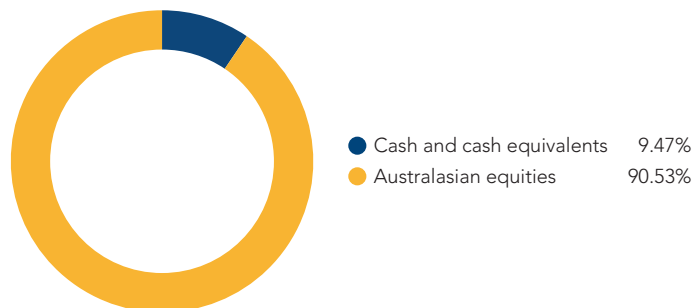
Example of how this applies to an investor

Katie had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Katie received a return after fund charges were deducted of \$2,064 (that is 20.64% of her initial \$10,000). Katie did not pay other charges. This gives Katie a total return after tax of \$2,064 for the year.

What does the fund invest in?

Actual investment mix

Currency hedging

The benchmark currency hedge ratio for Australian equities is 70% hedged into NZD. As at 30 June 2018 the fund was 54.1% hedged into NZD.
