What is the purpose of this update?

This document tells you how the Australian Growth Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. The fund aims to achieve capital growth over the long term by investing in quality Australian companies who can consistently produce increasing earnings.

What are the risks of investing?

Risk indicator for the Australian Growth Fund:



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.

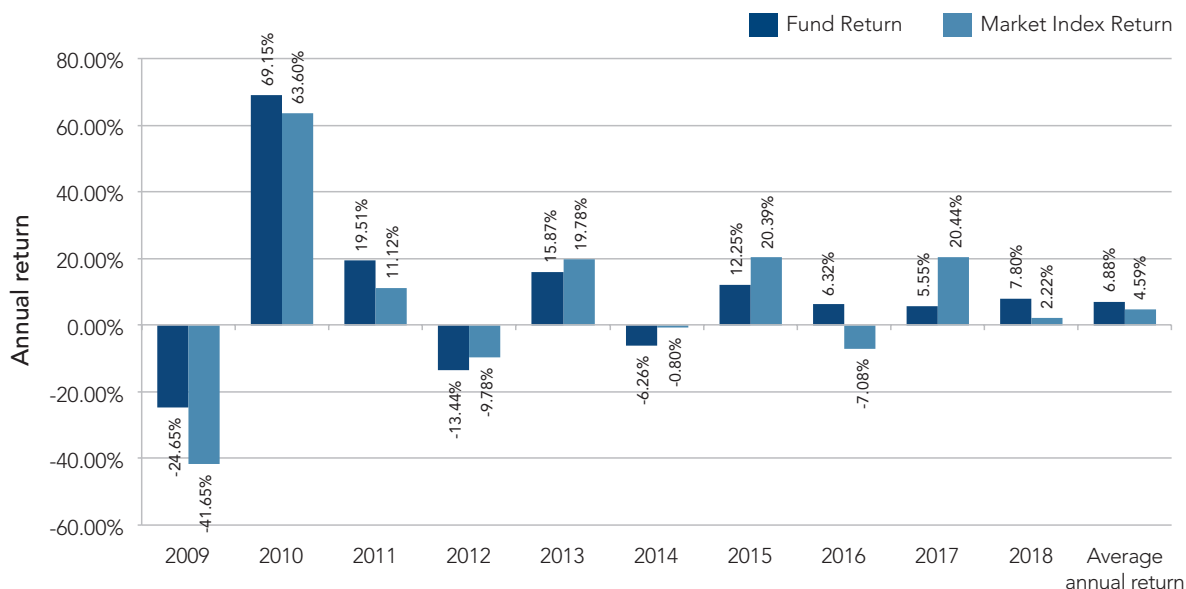

How has the fund performed?

What fees are investors charged?

Investors in the Australian Growth Fund are charged fund charges. In the year to 31 March 2017 these were:

Small differences in fees and charges can have a big impact on your investment over the long term.

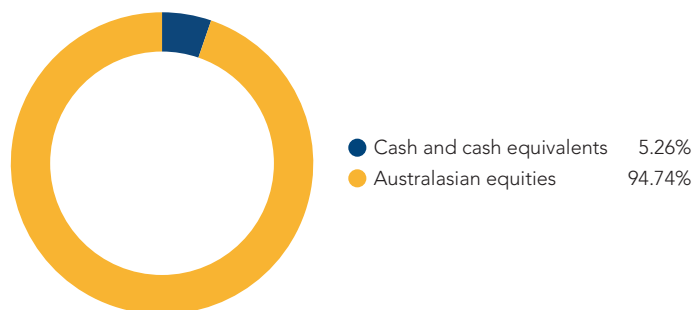
Example of how this applies to an investor

Katie had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Katie received a return after fund charges were deducted of \$780 (that is 7.80% of her initial \$10,000). Katie did not pay other charges. This gives Katie a total return after tax of \$780 for the year.
