

Fisher Funds KiwiSaver Scheme Growth Fund

Annual disclosure statement for 1 April 2015 to 31 March 2016

What is the purpose of this statement?

This statement provides key information about the Fisher Funds KiwiSaver Scheme Growth Fund. It tells you how the fund has performed and what fees it charged, and will help you to compare it with other funds. We prepared this statement in accordance with the KiwiSaver (Periodic Disclosure) Regulations 2013. This information is not audited and may be updated.

Description of the fund

The Growth Fund principally invests in growing companies in all or any of the New Zealand, Australian and other international share markets. Our investment objective for the Growth Fund is to grow the value of members' capital by investing in a hand-picked portfolio of high quality investments.

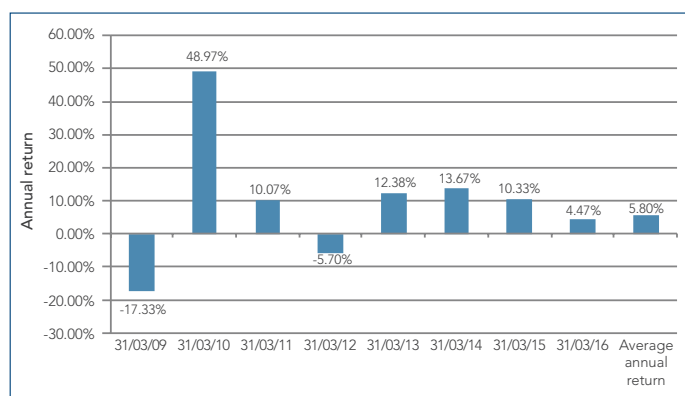

How has the fund performed in the past?

What fees were members charged?

The returns shown are after deductions for **fund fees**². These fees were last totalled up for the year to 31/03/2016 and were:

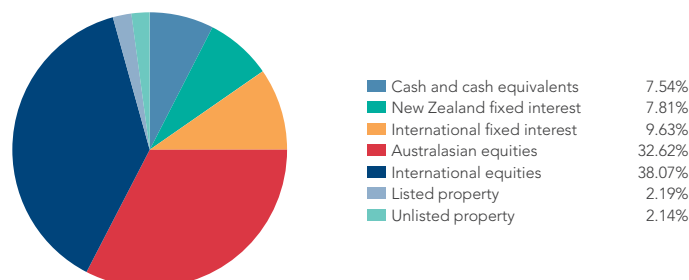
Example of how this applies to a member

Jenny had \$10,000 in the fund at the start of the year and didn't make any further contributions. At the end of the year, Jenny received a return after fund fees and tax were deducted of \$447 (that's 4.47% of her initial \$10,000). Jenny also paid \$36 in membership fees. This gives Jenny a total return of \$411 for the year.

Notes

- ¹ Returns in this statement are after tax at the highest prescribed investor rate (PIR) of tax for an individual New Zealand resident. Your tax rate may be lower.
- ² Fund fees are fees charged as a percentage of a member's interest in the fund (i.e. as a percentage of their KiwiSaver account balance).
- ³ Membership fees are the fixed dollar charges for membership in the Fisher Funds KiwiSaver Scheme.
- ⁴ Members who joined the scheme on or before 30 April 2011 were charged membership fees of \$24 over the year to 31/03/2015.
- * The negative performance fee expense as at 31 March 2016 is a result of the actual performance fee charged to the fund at 30 June 2015 (0.30%) being lower than the fee accrued to 31 March 2015 (0.32%). Because the performance fee period runs from 1 July to 30 June each year and the Annual Disclosure Statement period runs from 1 April to 31 March each year negative performance fee accruals as at 31 March are possible in these types of situations.
