

Fisher Funds KiwiSaver Scheme Growth Fund

Quarterly disclosure statement for 1 April 2013 to 31 March 2014

What is the purpose of this statement?

This statement provides key information about the Fisher Funds KiwiSaver Scheme Growth Fund. It tells you how the fund has performed and what fees it charged, and will help you to compare it with other funds. We prepared this statement in accordance with the KiwiSaver (Periodic Disclosure) Regulations 2013. This information is not audited and may be updated.

Description of the fund

The Growth Fund principally invests in growing companies in all or any of the New Zealand, Australian and other international share markets. Our investment objective for the Growth Fund is to grow the value of members' capital by investing in a hand-picked portfolio of high quality investments.

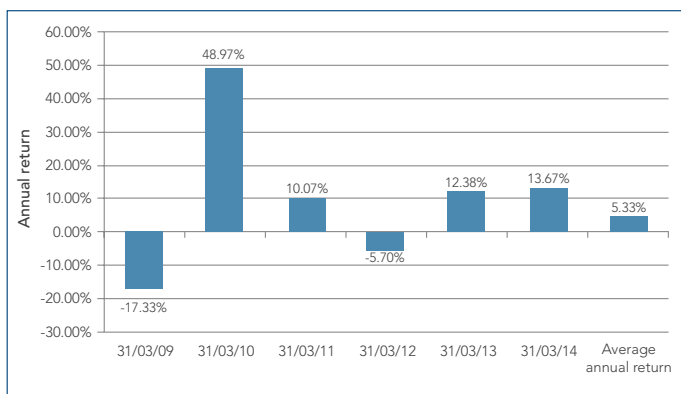

How has the fund performed in the past?

What fees were members charged?

The returns shown are after deductions for fund fees². These fees were last totalled up for the year to 31/03/13 and were:

Members were also charged **membership fees**³ of \$36 over the year to 31/03/13⁴.

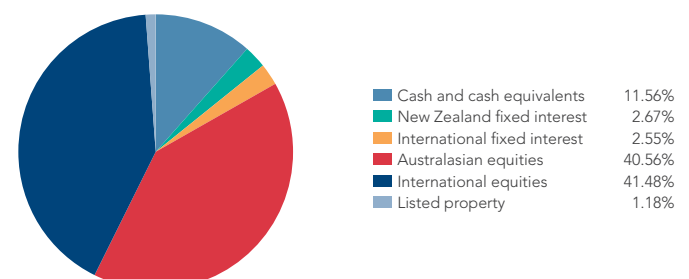
Example of how this applies to a member

Jenny had \$10,000 in the fund at the start of the year and didn't make any further contributions. At the end of the year, Jenny received a return after fund fees and tax were deducted of \$1,367 (that's 13.67% of her initial \$10,000). Jenny also paid \$36 in membership fees. This gives Jenny a total return of \$1,331 for the year.

² Fund fees charged as a percentage of a member's interest in the fund (i.e. as a percentage of their KiwiSaver account balance).

³ Membership fees are the fixed dollar charges for membership in the Fisher Funds KiwiSaver scheme.

⁴ Members who joined the scheme on or before 30 April 2011 were charged membership fees of \$24 over the year to 31/03/13.

*As at the date of this disclosure statement we have reasonable grounds to believe that the Total Fund Fees ('TFF') as at 31 March 2014 are 1.89%. This is due to a reduction in fund costs as a percentage of the value of the fund as a result of the increased value of the fund, and also because the performance fee as at 31 March 2014 is less than the performance fee included in the TFF as at 31 March 2013.
