What is the purpose of this statement?

This statement provides key information about the Fisher Funds KiwiSaver Scheme Growth Fund. It tells you how the fund has performed and what fees it charged, and will help you to compare it with other funds. We prepared this statement in accordance with the KiwiSaver (Periodic Disclosure) Regulations 2013. This information is not audited and may be updated.

Description of the fund

The Growth Fund principally invests in growing companies in all or any of the New Zealand, Australian and other international share markets. Our investment objective for the Growth Fund is to grow the value of members' capital by investing in a hand-picked portfolio of high quality investments.



How has the fund performed in the past?*

What fees were members charged?

The returns shown are after deductions for **fund fees**². These fees were last totalled up for the year to 31/03/2014 and were:


Example of how this applies to a member

Jenny had \$10,000 in the fund at the start of the year and didn't make any further contributions. At the end of the year, Jenny received a return after fund fees and tax were deducted of \$1,033 (that's 10.33% of her initial \$10,000). Jenny also paid \$36 in membership fees. This gives Jenny a total return of \$997 for the year.

Information about conflicts of interest

There has been a material change in the nature of the Fund's related party transactions during the quarter. As at the end of the quarter the fund has invested 0.96% of its assets in the Fisher Institutional International Equity Fund and 3.98% of its assets in the Fisher Institutional Equity (Hedged) Fund. These are wholesale funds managed by Fisher Funds Management Limited and therefore represent related party transactions. The transactions to invest in these wholesale funds were entered into on an arm's-length basis.

¹ Returns in this statement are after tax at the highest prescribed investor rate (PIR) of tax for an individual New Zealand resident. Your tax rate may be lower.

² Fund fees are fees charged as a percentage of a member's interest in the fund (i.e. as a percentage of their KiwiSaver account balance).

³ Membership fees are the fixed dollar charges for membership in the Fisher Funds KiwiSaver Scheme.

⁴ Members who joined the scheme on or before 30 April 2011 were charged membership fees of \$24 over the year to 31/03/2014.

* As at the date of this disclosure statement we have reasonable grounds to believe that the Total Fund Fees ('TFF') as at 31 March 2015 is likely to be 1.42% for the year to 31 March 2015. This is because the current accrued performance fee as at 31 March 2015 is less than the performance fee included in the TFF as at 31 March 2014.

** How has the fund performed in the past? - In the original QDS for 31 March 2015 the annual return for the year to 31 March 2015 was omitted from the bar chart. This return has now been added.
